The Reservation List Fee entitles the Buyer to _____ Pick Position for the _____ litter by _____ & _____ (or similar sire). Buyer acknowledges the Reservation List Fee **does not guarantee a specific puppy, nor specific attributes including color, sex, coat type, temperament, or pattern will be available to the Buyer on Pick Day.** Pick day is typically on/after the litter turns 7 weeks of age to allow for temperament testing prior to selection. The Buyer may be required to Pick their puppy via Facetime/Zoom appointment if in person selection is not possible for any reason. The Reservation List Fee shall be credited to the final Purchase Price if a purchase is made.

- The Cash Purchase Price for a puppy is \$ _____. The remaining balance \$ _____ of the is due on Go Home Day.
- Zelle payments also qualify for Cash Price above. We do NOT accept payments via Venmo or Raypal.
- The Purchase Price of a puppy when paid for via the Good Dog payment platform is \$ _____ therefore the remaining balance of \$ _____ would be due on Go Home Day. Payment plans or credit card payments are available ONLY through Good Dog.

There is a \$25 per day boarding fee for any puppy not picked up by 8 weeks of age. If the Buyer elects to pick up after the litter's Go Home Day, the full Purchase Price must be paid by the time the puppy turns 8 weeks of age. Fees associated with boarding can be paid on the day the Buyer takes possession of the puppy in case the duration of boarding needs to be changed.

If the dam listed above fails to get pregnant, the Buyer will have the option to receive a refund OR transfer to a future litter. So long as the litter produces at least as many puppies as the Buyer's pick position, the Reservation List Fee is non-refundable. If the Buyer elects not to pick a puppy from the litter agreed upon above for any reason, the Reservation List fee can be transferred to a future litter. Transferring to a future litter does not guarantee the same Pick Position. Breeder always reserves the right of 1st & 2nd pick to any/all litters and if there are already other Buyers on the subsequent litter's list, this Buyer will be assigned the next available Pick Position. If the Buyer has not selected a puppy within 24 months of the contract date, the Reservation List Fee will be forfeited and the Breeder owes the Buyer no further obligations

The puppy will be sold with a Pet Purchase Agreement that includes a 2-year Health Guarantee and a return to breeder/no resale clause. A copy of contract is available upon request. The Purchase Price does NOT include breeding rights. If at ANY POINT, the Breeder feels the sale of the puppy to the Buyer is not in the best interest of the puppy, the Breeder reserves the right to cancel the sale.
